

Make memories this May at the Suffolk Show. Monthly Member Prize Draw - May.

Terms and Conditions

5. The opening date for entries is 12pm on Thursday 7 May 2026. The closing date of the prize draw is 5pm on Tuesday 19 May 2026. Entries received after this time will not be considered.
6. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
7. One member will be chosen by a random draw performed by a computer process on Wednesday 20 May 2026 ("Draw Date").
8. One member will receive 2 adult tickets for the Suffolk Show 2026. Children under the age of 15 enter for free. Tickets can be used on either Wednesday 27 May 2026 or Thursday 28 May 2026 but can only be used once.
9. The winner will be notified by email (using details provided at entry) by Thursday 21 May 2026. If a winner does not respond to the Promoter within two days of being notified by the Promoter, then the winner's prize will be forfeited, and the Promoter will be entitled to select another winner in accordance with the process described above.

10. The prize will either be sent to the winner by email within 14 days of being notified of their win, or the winner can visit their local Suffolk Building Society branch to collect it.
11. The prize for the winner is non-exchangeable, non-transferable and no cash alternative is offered.
